(a) The \$A10,000 Australian microbrewery excise tax rebate in the Tax Expenditure Statements from 2001 to 2011-12 has been rounded down or up to the nearest \$m. For the years 2004-05 to 2011-12, the rebate figure is rounded down to \$Nil. This means that the actual rebate paid is less than \$A0.5m per year as it has been rounded down probably because not many breweries were eligible.

## From 2004-05 to 2011-12, small producer rebates have been 0.02% of beer excise revenues and 28% of wine equalisation tax revenues in Australia. The table above shows the inequality between the tax burden of the Australian wine and beer industry.
